

## **PARTICIPATION AND OPERATING RULES**

## **ELIGIBILITY**

- Participation is exclusively reserved for individuals aged 18 and over who are physically located in the province of Quebec at the time of the ticket purchase.

## **DRAW DETAILS**

- This is a 50/50 draw where the winner will receive fifty percent (50%) of the gross revenue generated from ticket sales. The remaining half will be retained by Banque alimentaire Memphrémagog to help fund its operations.

## **HOW TO PARTICIPATE**

Tickets will be sold online via the Moitiemoitie.com website: <https://www.moitiemoitie.com>

- Sales Period: Starts March 2, 2026, and ends June 2, 2026, at 8:00 AM.
- Draw Date: June 4, 2026, at 10:00 AM.

When purchasing tickets through the online platform, participants will receive a digital receipt by email indicating the numbers associated with the purchased tickets. Promotion: For all orders placed between March 2, 2026, and March 23, 2026, buyers will automatically receive double the number of tickets purchased as part of the "Double Your Chances" promotional period.

During the online purchase, participants must provide their contact information to buy tickets and be eligible for the draw. The total number of tickets for sale is unlimited. The first number is #A-1001.

Ticket Prices:

- 3 tickets for \$10
- 10 tickets for \$25
- 100 tickets for \$100

## **DRAW AND CONTACTING THE WINNER**

- The winning ticket number will be selected by an electronic random number generator from all numbers sold during the draw period.
- The winning number and prize details will be announced on the Banque alimentaire Memphrémagog Facebook page following the draw.
- The prize amount will be equal to 50% of the gross ticket sales revenue. In the event that the announced (displayed) amount and the total amount collected are not identical, the latter shall prevail.
- The winner will have fourteen (14) business days from the draw date to claim their prize by contacting Banque alimentaire Memphrémagog via their Facebook page. To facilitate the awarding of the prize, the organization will also use the contact information provided at the time of purchase to reach out to the winner during the claim period.
- The winner must provide two pieces of identification showing their name, address, and date of birth, one of which must be a photo ID. Only the holder of the winning ticket may claim the prize.
- If the winning ticket holder has not claimed the prize within the 14-business-day period, the prize amount will be awarded to Banque alimentaire Memphrémagog to support its operations.
- The winner must complete a Declaration and Release of Liability form before taking possession of their prize. The prize is non-transferable and must be accepted as is, with no substitutions. Banque alimentaire Memphrémagog assumes no responsibility toward any other person claiming an interest or right to receive all or part of the prize associated with the winning ticket.
- The prize will be paid by check by Banque alimentaire Memphrémagog within thirty (30) business days following the prize claim.

## **OTHER GENERAL CONDITIONS**

- No official tax receipt will be issued for the purchase of raffle tickets, as per Canada Revenue Agency regulations.
- All ticket sales are final. No refunds will be issued for any reason. Tickets purchased cannot be refunded, even if the buyer made an error in selecting the amount of tickets they wished to purchase.
- Tickets are subject to verification by the organizers. Any fraudulent ticket will be automatically rejected and will not entitle the holder to a prize.
- If the integrity of the draw is compromised in any way, Banque alimentaire Memphrémagog will notify the Régie des alcools, des courses et des jeux du Québec (RACJ) and consult them on the best course of action.
- Banque alimentaire Memphrémagog must receive approval from the RACJ before canceling the draw or modifying the draw rules.
