

2026 Municipal Tax Account

Dear Notre-Dame-de-l'Île-Perrot Residents,

During our December 15 special meeting, council members and I approved the 2026 budget and the 2026–2027–2028 three-year capital expenditure program.

In spite of significant increases to recurring expenses and infrastructure maintenance and construction work costs, we were able to present a balanced budget and maintain one of the lowest tax rates in the area, while preserving the sense of community and quality of life so important in Notre-Dame-de-l'Île-Perrot.

In order to balance the 2026 budget, we had to make decisions guided by our long-term vision and careful consideration of our financial capacity.

Despite considerable increases in infrastructure management expenses and drastic cuts in government subsidies, we must continue to move forward. With this in mind, we have opted to create contingency funds for drinking water and wastewater infrastructure. These funds will help us to maintain more kilometres of our water and sewer networks over the years, while limiting the use of borrowing by-laws, which is more costly for us given the interest payments involved.

Maintaining our water supply network is just one part of a comprehensive drinking water management strategy to be implemented in 2026. While the City continues to maintain its infrastructure, we all need to collectively reduce our water consumption. Among the cities supplied by the Régie de l'eau, Notre-Dame has the highest rate of water consumption, well above the provincial target. While this high consumption rate presents environmental and economic challenges, it may also disqualify the City from certain government subsidies. Part of our strategy involves installing smart water meters in new developments, while phasing out older meters that are reaching the end of their useful lifecycle. We will eventually be able to use the data from smart meters to verify the results of our efforts to eliminate leaks and to reduce residential water consumption.

In 2026, the City will pursue its work on the Parc Nature project in the municipal workshop area, at the corner of Perrot and Don-Quichotte Boulevards. This project, initiated more than four years ago, will preserve 46 hectares of natural environments, including trails. We are continuing our work with the CMM and various governments to acquire the necessary funding and approval. There will be a public meeting in 2026 where we can update you on the progress of this project.

Since the last elections in November, there has been a new sense of municipal collaboration sweeping across Île Perrot. My fellow council members and I are eager to work with all elected officials on projects that build community, including the new sports centre on the island, while we will pursue inter-municipal agreements that will benefit all residents of the cities on Île Perrot.

ONLINE TAX PAYMENT

Municipal taxes can be paid online through your financial institution's website, just like any other bill.

In the list of payees, look for one of the following options:

- VILLE DE NOTRE-DAME-DE-L'ÎLE-PERROT
- MUNICIPALITÉ DE NOTRE-DAME-DE-L'ÎLE-PERROT

Then enter the 18-digit roll number shown on your tax bill or the reference number on the payment coupon.

While online payment saves you time and fees and supports sound municipal financial management, you may also pay in person at City Hall or at the One-Stop Service Desk.
